## **LEASE / PURCHASE AGREEMENT**

- The initial 4-month rental is valid once only and cannot be renewed. You will be billed monthly if you continue after the initial 4 months.
- This is not a sales contract. The musical instrument remains the sole property of HMI Corp. until full payment is received.
- The instrument may be returned and this agreement canceled at any time.
- All monthly rental payments are applied to ownership of the instrument you are renting. Rental must be continuous to apply to ownership and must be made in a timely manner. Rental credit does not include the 4-month "Special" payment or the cost of Service and Replacement Coverage.
- Accounts that are terminated forfeit all purchase credit. Consider keeping the instrument during the summer if your child plans to continue music in the fall.
- Exchanges can be made with a \$20.00 administrative fee. 50% rental credit will be applied to another rental instrument.
- No plan payment credit will be issued in the form of store credit or reinstated at a later date.
- All original accessories must be returned with the instrument to avoid being billed for their replacement.
- There will be a \$40.00 returned check fee.
- Do not post date checks. All checks will be deposited when received.
- Bankruptcy: If bankruptcy is filed, the instrument must be returned immediately.

## **DISCOUNTS**

- A 40% discount is available for outright purchase of an instrument or off the unpaid balance of your rental instrument.
- Payments must be current for discount to apply.

## **CONTRACT CANCELLATION AND INSTRUMENT RETURN**

- IF DISCONTINUING YOUR RENTAL, DO NOT RETURN YOUR INSTRUMENT TO YOUR CHILD'S SCHOOL. YOU ARE RESPONSIBLE FOR RENTAL PAYMENTS UNTIL HUNTERDON MUSIC RETAINS PHYSICAL POSSESSION OF THE INSTRUMENT. CONTACT HUNTERDON MUSIC DIRECTLY IF YOU WISH TO DISCONTINUE YOUR RENTAL.

## **DELIVERY AND PICKUP**

- Free delivery and pickup of rentals, repairs and accessories is available at schools serviced regularly by Hunterdon Music at Hunterdon Music's discretion. Please contact us to see if your school is serviced.

## **WARRANTY**

- All instruments are covered during the rental period under the terms of the Service and Replacement Coverage outlined in the next section.
- A 90-day warranty covering repairs not caused by negligence or mischievous conduct ensues from the date of purchase or payment in full of your account. Strings, reeds, broken mouthpieces, lacquer deterioration, dents and cracks and all originally issued accessories are not covered.
- Payments must be current for the warranty to apply.

## **SERVICE AND REPLACEMENT COVERAGE**

Hunterdon Music will on all current accounts:

- Provide regular maintenance as needed. NOTE: All repairs must be done by Hunterdon Music
- Repair rental instrument to playable condition for repairs not caused by negligence or mischievous conduct at no cost. Strings, reeds, broken mouthpieces, lacquer deterioration, dents, cracks, cosmetic issues and all originally issued accessories are not covered.
- Replace the instrument with one of equal value in case of theft. We are not responsible for loss due to negligence (instruments left on bus, playground, etc.) Stolen instruments must be reported to the local police within 48 hours and to Hunterdon Music within 10 days in writing or replacement will be void and customer will be responsible for loss. A copy of the police report is needed for replacement. Your account must be within 15 days current or you will be responsible for the costs of the loss.
- The Service and Replacement Coverage ("S & R Coverage") charge is \$7.00 monthly in addition to the "Monthly Renewal" cost. Coverage is not optional.

## **STRING INSTRUMENTS**

- Size changes are necessary with the rental of string instruments. Hunterdon Music will make size exchanges with all applicable rent monies applied to the next size instrument.

## **PAST DUE ACCOUNTS**

- ACCOUNTS 15 DAYS PAST THE PAYMENT DUE DATE ARE CONSIDERED DELINQUENT AND A \$8.00 LATE FEE IS ASSESSED EACH MONTH THE PAYMENT IS PAST DUE. ACCOUNTS THAT ARE 60 DAYS PAST DUE ARE SUBJECT TO THE FOLLOWING:
  - A COLLECTION FEE OF 30% OF THE OUTSTANDING AMOUNT TOGETHER WITH ALL LATE FEES AND ANY COURT COST INVOLVED
  - PICKING UP THE INSTRUMENT WITHOUT PRIOR NOTICE
  - CANCELLATION OF ANY DISCOUNT OPTION
